By my signature below, I acknowledge that I have the legal authority to sign this Consent and Waiver form.

2. I am applying for a Certificate of Appropriateness from the Borough of North Plainfield Historic Preservation Commission ("NPHPC"), pursuant to Borough Ordinance, Article VIII, Section 22-122.5.

3. I understand that designated members of the NPHPC, in order to familiarize themselves with the property listed in Paragraph 1 above prior to determining whether to grant my application, wish to enter upon such property for the sole purpose of inspecting and photographing same.

4. I understand that such inspection will be limited to: 1) any front and side yards in the public view; 2) the front and sides of any structures in the public view; 3) any driveways and sidewalks in the public view; 4) any walls or fences in the public view; and, 5) any other unique or historic features of the property in the public view.

5. I understand and agree that such inspection will take place only during daylight hours and in an unobtrusive manner. I may or may not be given prior notice of the inspection, but the designated members will try to do so.

6. I hereby give my full and unconditional consent to the inspection outlined above.

7. I understand and agree that I have the right to withhold my consent to this inspection and that such refusal shall not affect the NPHPC's determination of my application.

8. In addition to giving my full and unconditional consent to the inspection outlined above, I hereby waive, release, and forever discharge and hold harmless the Borough, the NPHPC, members of the NPHPC, and their officials, employees, agents, designees, officers and representatives from any and all liability, claims and demands of any kind or nature whatsoever that arise or may hereafter arise from such inspection.
